Could you please provide the legal name of the State Park where the homeless encampment is located? **No particular State Park, the land is owned and managed by State Parks.**
When was the State Parks agency made aware of this encampment? **I don't know exactly when they were made aware of it. But I think more than a year ago.**

Who is the lead for the homeless outreach team with Malibu City? **The City contracts with The People Concern, which is based in Santa Monica. Richard Song and Zach Coil (supervisor) are the leads. The best way to reach them is to call 310-460-2638. Luis Flores manages the contract and is also a good contact: 310-456-2489 x236.**

Could you also provide the name of the Sheriff's Deputy who handles homeless issues, as mentioned in the previous response? **Deputy Frank Espinosa.**

What is Luis Flores' official title and role within Malibu City? **Luis' title is Public Safety Liaison and he coordinates the City's response to homeless issues and assists with other law enforcement related safety issues. He's out sick today, but if you call him or e-mail him, I'm sure he will respond as soon as he returns.**
